## NEXHAUL TRAILERS LIMITED WARRANTY DURATION OF WARRANTY

#### LIMITED WARRANTY

Nexhaul Trailers, 305 New Plant Road, Rocky Mount VA 24151 warrants to the original consumer purchaser for a period of three (3) years from the date of the purchase by the purchaser that its trailer shall be free of DEFECTS in material and workmanship attributable to warrantor. Excluded from this three (3) year warranty are electrical, plumbing, windows, glass, doors, sealant, paint, undercoating axles, suspension, and fiberglass parts which are warranted for a one (1) year period from the date of purchase by the original purchaser. Side door flush locks are covered for a period of six (6) months. Nexhaul Trailers will NOT pay for any warranty issues outside The Continental USA.

#### EXCLUDED FROM WARRANTY

Warrantor is not responsible for claims related to: (1) defacing, scratches, dents, chips, tears on any surface not caused by warrantor; (2) routine maintenance; (3) damage from unauthorized repairs, abuse, misuse or neglect; (4) damage caused by improper hitch ball or tow hook up; (5) component parts covered by separate supplier warranty. Nexhaul Trailers reserves the right for final determination whether or not the product has been abused or misused.

#### WARRANTOR'S OBLIGATION

Warrantor shall elect to remedy defects in materials in workmanship caused by warrantor by repair, replacement or refund if replacement or repair is not possible. All defective products shall be delivered to warrantor's address above unless prior written approval is obtained from warrantor. Warrantor may select another qualified location for repair to be completed. Warrantor will not be obligated, in any way, to pay for repairs made without its specific approval. All cost incurred in shipping or delivery of product for warranty service shall be borne by purchaser. Warrantor shall remedy defects within a reasonable time, not to exceed sixty (60) days after delivery by purchaser. Warrantor must be notified before any work performed will be paid.

#### PURCHASER'S OBLIGATION

#### LIMITATIONS AND DISCLAIMER OF IMPLIES WARRANTY

Warrantor expressly limits the duration of all implies warranties of merchantability, fitness for a particular purpose and other implies warranties to the warranty period of three (3) years. The warrantor expressly disclaims all implies warranties after expiration of warranty date. No person has the authority to enlarge, amend or modify this warranty.

#### DESIGN CHANGE
